

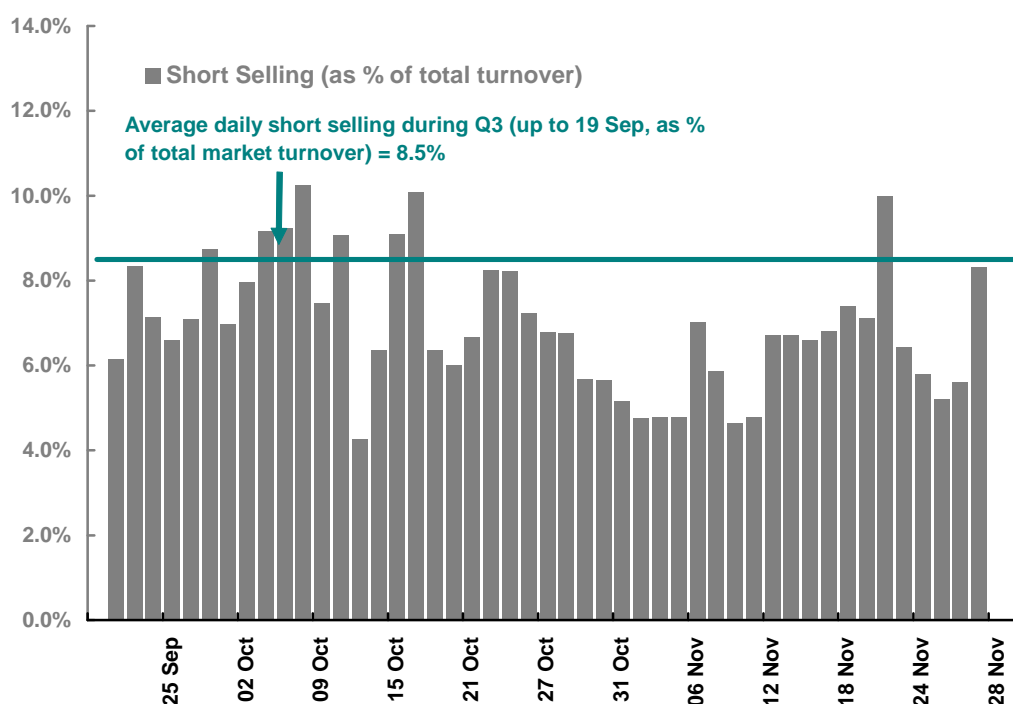

Weekly update on Hong Kong's short-selling pattern (24 November to 28 November)

Local short-selling turnover last week was similar to levels recorded earlier in the third quarter and in the whole of the second quarter. During the week (24 November to 28 November), the average daily short-selling turnover was \$2.7 billion or 6.4% of the total market turnover, compared to:

- \$5.7 billion or 7.4% for the second quarter;
- \$5.4 billion or 8.5% for the third quarter up to 19 September; and
- \$4.1 billion or 7.0% for 22 September to 21 November.

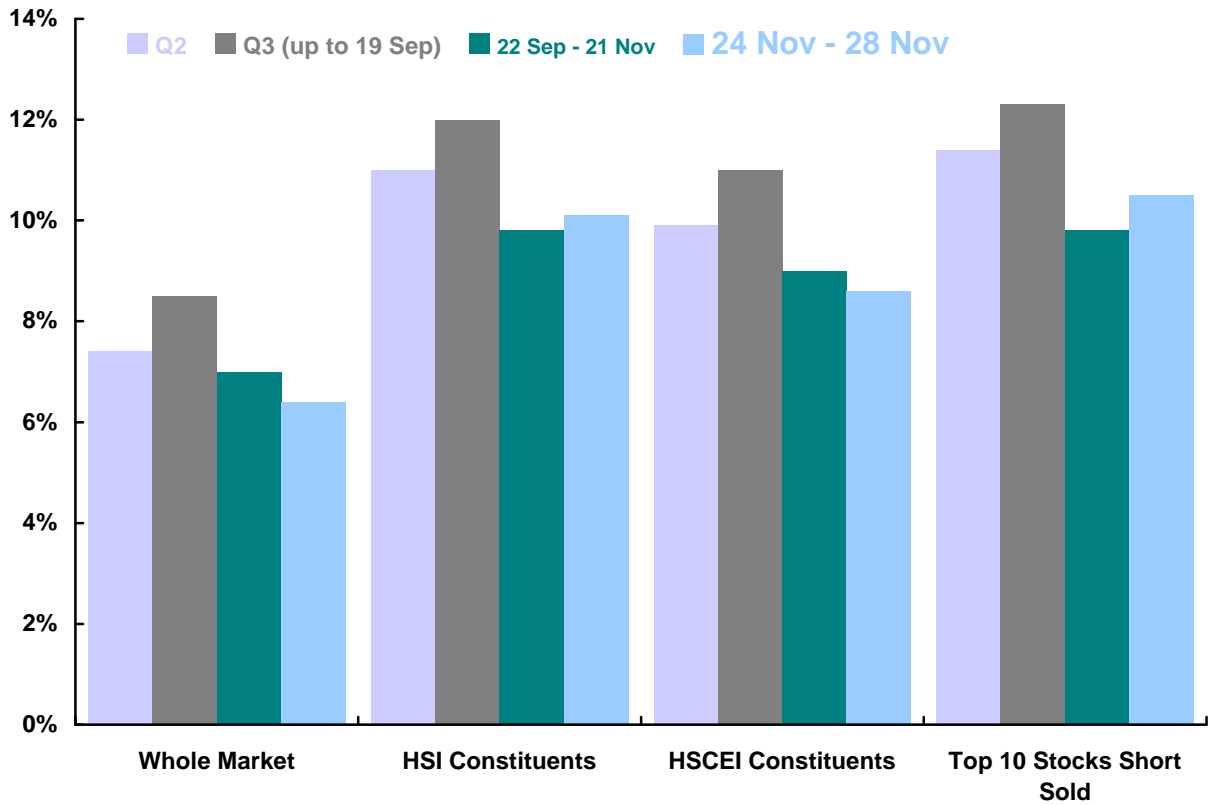
