

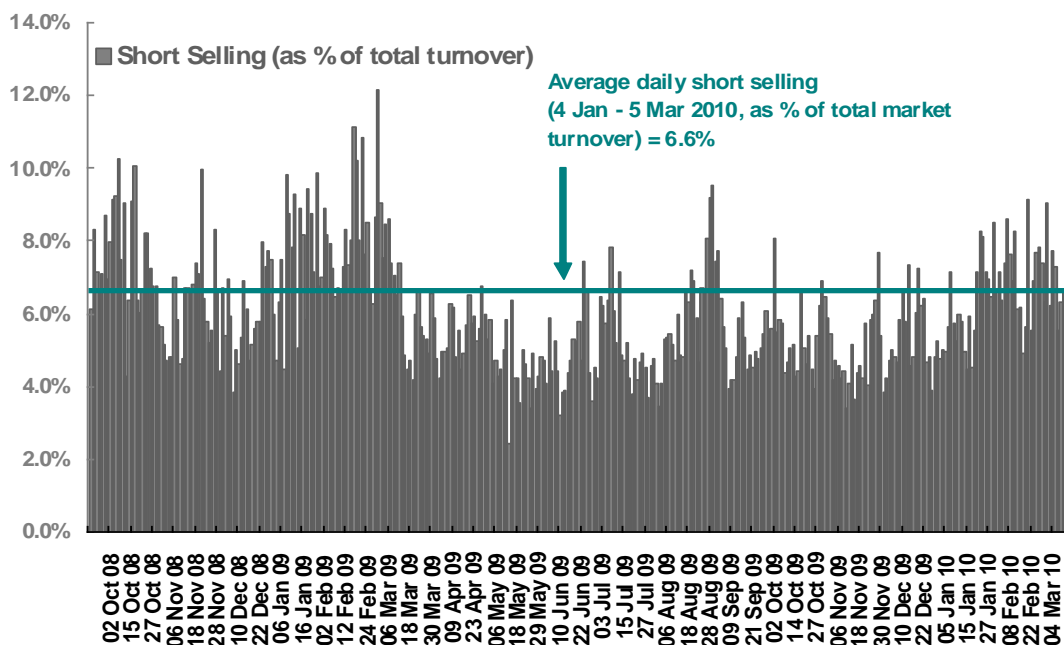

### Weekly update on Hong Kong's short-selling pattern (8 March to 12 March 2010)<sup>1</sup>

Compared to earlier period, local short-selling turnover was lower in both absolute terms and relative to total market turnover. During the week (8 March to 12 March 2010), the average daily short-selling turnover was \$3.4 billion or 5.9% of the total market turnover, compared to:

- \$5.4 billion or 8.5% for the third quarter in 2008 up to 19 September 2008;
- \$3.5 billion or 6.6% for 22 September to 31 December 2008;
- \$3.2 billion or 7.2% for the first quarter in 2009;
- \$3.4 billion or 4.8% for the second quarter in 2009;
- \$3.6 billion or 5.4% for the third quarter in 2009;
- \$3.4 billion or 5.3% for the fourth quarter in 2009; and
- \$4.5 billion or 6.6% for 4 January 2010 to 5 March 2010.

Recent short-selling turnover patterns for Hang Seng Index constituents, Hang Seng China Enterprises Index constituents and the top 10 short-sold stocks are also shown below.

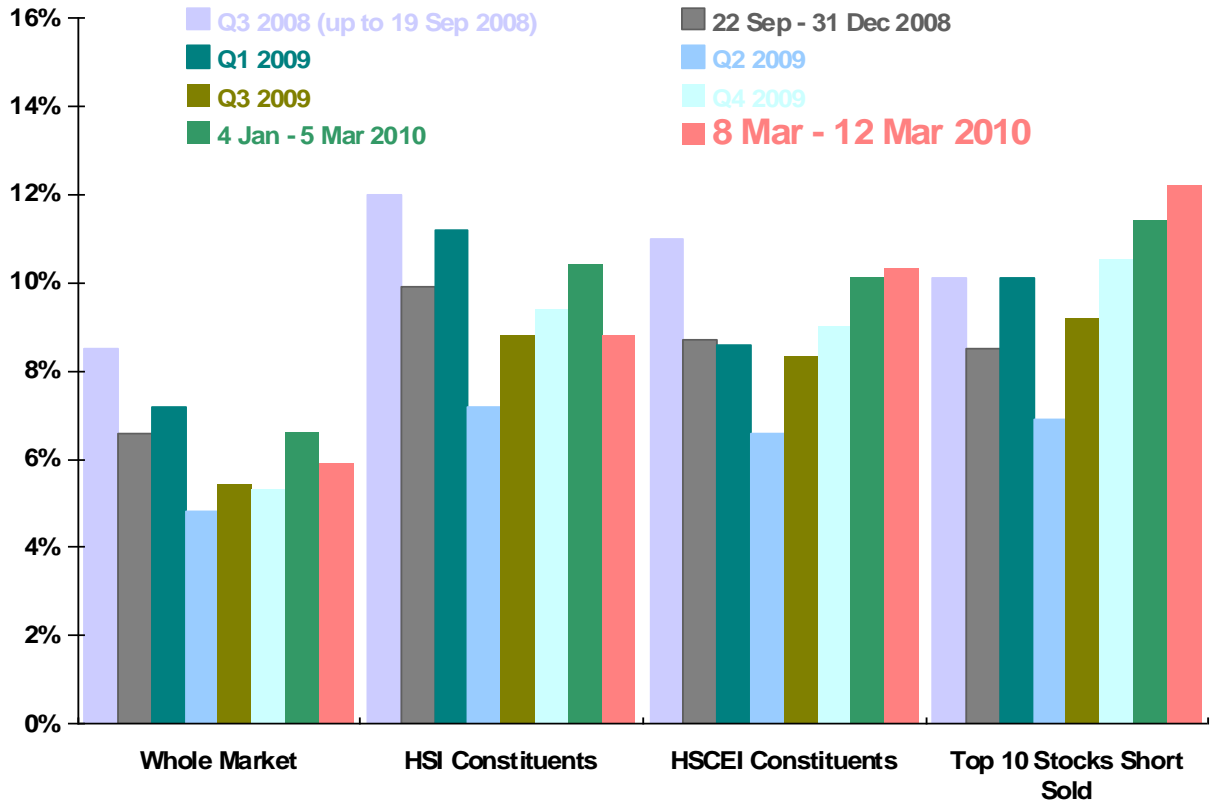


### Total Short Selling Turnover in Hong Kong (as percentage of total market turnover)
