IT IS ORDERED that:

1. Pursuant to section 214(2)(a) and (d) of the Securities and Futures Ordinance, Cap. 571, the 5th Respondent shall not, without leave of the Court, for a period of 33 months with effect from the date of this order:
 - (a) be, or continue to be, a director, liquidator, or receiver or manager of the property or business, of any listed or unlisted corporation in Hong Kong including China Candy Holdings Limited (“**Company**”) or any of its subsidiaries and affiliates; and
 - (b) in any way directly or indirectly be concerned, or take part, in the management of any listed or unlisted corporation in Hong Kong including the Company or any of its subsidiaries and affiliates.
2. The 5th Respondent do pay the costs of the Petitioner in these proceedings, to be taxed if not agreed.
