  - (1) be, or continue to be, a director, liquidator, or receiver or manager of the property or business, of any listed or unlisted corporation in Hong Kong including China Candy Holdings Limited ("Company") or any of its subsidiaries and affiliates; and
  - (2) in any way directly or indirectly be concerned, or take part, in the management of any listed or unlisted corporation in Hong Kong including the Company or any of its subsidiaries and affiliates.
- 2. The 6<sup>th</sup> Respondent do pay the costs of the Petitioner in these proceedings, in the sum agreed with the Petitioner.
