**High Concentration of Shareholding
in
Planetree International Development Limited (Stock Code: 00613)**

This announcement is made by the Securities and Futures Commission (“SFC”) in respect of the concentration of the shareholding of Planetree International Development Limited (the “Company”) in the hands of a limited number of shareholders as at 13 August 2026.

In view of the high concentration of shareholding in a small number of shareholders, shareholders and prospective investors should be aware that the price of the shares of the Company (“Shares”) could fluctuate substantially even with a small number of Shares traded, and should exercise extreme caution when dealing in the Shares.

The SFC has recently completed an enquiry into the shareholding of the Company. Our findings suggested that, as at 13 August 2026, 20 shareholders held an aggregate of 161,259,000 Shares, representing 14.03% of the issued Shares. Such shareholding, together with 902,262,175 Shares (representing 78.48% of the issued Shares) held by 3 substantial shareholders of the Company, represented 92.51% of the issued Shares. As such, only 86,112,035 Shares (representing 7.49% of the issued Shares) were in the hands of other shareholders.

Note 1: 5,271,800 Shares were held by Ms. Lo Ki Yan Karen, and 628,263,640 Shares were held by Future Capital Group Limited (a company wholly-owned by Ms. Lo Ki Yan Karen).

Note 2: 197,890,935 Shares were held by Kenson Investment Limited, and 4,016,000 Shares were held by Smart Jump Corporation. These companies are wholly-owned subsidiaries of Oshidori International Holdings Limited (Stock Code: 00622).



The closing price of the Shares rose 339% from HK\$1.260 on 2 March 2026 to HK\$5.535 on 13 August 2026.

As at 26 August 2026, the price of the Shares closed at HK\$4.900, representing an increase of 289% from the closing price of HK\$1.260 on 2 March 2026.
