Ms Julia Leung, SBS, JP
Chief Executive Officer, Securities and Futures Commission

Ms Julia Leung has been Chief Executive Officer (CEO) of the Securities and Futures Commission (SFC) since 1 January 2023.

Ms Leung joined the SFC in March 2015 as Executive Director of the Investment Products Division. She became Executive Director of the Intermediaries Division in June 2016 and took on the additional capacity of Deputy CEO in March 2018.

In more than 25 years of public service, Ms Leung has extensive experience in financial regulation, market development and international cooperation. Prior to joining the SFC, Ms Leung was the Under Secretary for Financial Services and the Treasury from August 2008 to December 2013. Before that, she served at the Hong Kong Monetary Authority for 14 years, spending the last eight years as the Executive Director responsible for financial cooperation with Mainland and other international regulators. Currently, she is the Vice President of the Hong Kong Institute of Bankers and a council member of the Treasury Markets Association.

Ms Leung graduated from The Chinese University of Hong Kong and earned a master's degree from Columbia University in the City of New York. In 2014, she authored a book on how Asia has surmounted various financial crises.

Under Secretary for Financial Services and the Treasury, the Government of Hong Kong SAR

Mr Joseph Chan was appointed the Under Secretary for Financial Services and the Treasury on 16 August 2017.

Mr Chan has many years of senior executive experience in the banking industry. He was a Managing Director in the Global Markets Division of Credit Agricole Corporate & Investment Bank, and was a Managing Director in Financial Markets of Standard Chartered Bank.

Prior to joining the Government, Mr Chan held multiple roles in a number of public and professional bodies, including Vice President of the Hong Kong Society of Financial Analysts, Director of Hong Kong Securities & Investment Institute, Advisor of the Chinese Gold & Silver Exchange Society, as well as a General Committee member of the Hong Kong General Chamber of Commerce. Mr Chan was also a member of the Central & Western District Council.

Mr Chan holds a Bachelor of Arts in Economics (Hon) and Psychology from the University of Michigan, USA. He is also a Chartered Financial Analyst.

Dr Eric Yip is a member of the SFC. He is also an Executive Director heading the Intermediaries Division, which comprises the Intermediaries Supervision and Licensing departments. The Division is primarily responsible for administering licensing requirements and conducting ongoing supervision of licensed corporations with a focus on their business conduct and financial soundness.

Dr Yip is a seasoned financial professional having in-depth knowledge of the operation and regulation of the financial markets in Hong Kong and Mainland China. Prior to joining the SFC, he held senior roles in banking, asset management and Hong Kong Exchanges and Clearing Limited. He began his career as a Management Consultant at McKinsey and Company.

Dr Yip sits on the SFC's Executive Committee.



Mr Barry Lai

Assistant Commissioner (Intelligence and Investigation), Hong Kong Customs and Excise Department

Mr Barry Lai joined the Hong Kong Customs and Excise Department (C&ED) in 1994. He has taken up the current appointment as the Assistant Commissioner (Intelligence and Investigation) of the C&ED since April 2024. Currently, he oversees all the intelligence and investigation work in the Department including narcotics, intellectual property crimes, smuggling, illicit cigarette, organized crime and money laundering.

Since his promotion to Assistant Superintendent in 2012, Mr Lai's career in the C&ED was marked by extensive experience in the suppression of narcotics offences and syndicated smuggling activities, as well as the recovery and confiscation of proceeds arising from drug trafficking and organized crimes. In 2023, Mr Lai was appointed as the Head of Land Boundary Command, taking charge of operations at land boundary control points until assuming his current post after a year.

Ms Heddy Tsang is the Head of Exchange with HashKey. She is responsible for overall management oversight of HashKey Exchange, one of the first licensed virtual asset trading platforms in Hong Kong. She supervises the business development, product expansion, trading operations, compliance and risk management of the exchange.

Ms Tsang has over 20 years of experience in finance and has held a number of senior roles in both the traditional sector and the crypto industry. She was Head of Listed Products (Asia) at Societe Generale and Head of Distribution at ABN Amro Bank. Prior to HashKey, she was Head of Exchange with another virtual asset trading platform applicant in Hong Kong.

Ms Tsang has a master's degree in Economics from the University of Cambridge, UK.



Mr Ronnie Kung

Chairman, The Hong Kong Association of Online Brokers Limited

Mr Ronnie Kung acts as the Chairman of The Hong Kong Association of Online Brokers Limited (HKAOB) who promotes the affable relationships within the online securities and futures industry, and provides a forum for discussion and advice on issues related to the industry.

Mr Kung has been working in the Hong Kong financial market industry for more than 30 years. He is currently one of the Managing Directors and Responsible Officers (ROs) for BOCI Securities Limited, licensing with Types 1, 2, 4 and 5 regulated activities. Before joining BOCI, he had played the roles of Sales Manager and RO for HSBC Broking Securities (Asia) Limited for 20 years.

Mr Kung manages the securities and futures businesses of the company and supervises the Wealth Management, Employee Share Option Plan (ESOP) and Equity Derivative Trading businesses. In his daily management, using Regtech to combat financial crime and sustain compliance is the most crucial responsibility. Nevertheless, the Corporate Members of HKAOB also share the same view in applying technologies to various areas to ensure compliance.

Mr Keith Choy is the Senior Director and head of the SFC's Intermediaries Supervision Department which supervises over 3,000 financial intermediaries in Hong Kong including investment banks, securities dealers, futures brokers, financial advisers and asset managers. Mr Choy oversees key supervision activities such as carrying out on-site inspections of firms for the purpose of identifying and managing risky firms and detecting misconduct. He has also been actively involved in the formulation and implementation of policies and regulations for the securities and futures industry.

Mr Choy joined the SFC's Enforcement Division in 1998 and was in charge of the Intermediaries Misconduct Team before he moved to his current position in 2017. Prior to joining the SFC, Mr Choy practised as a solicitor in Hong Kong.

Principal Assistant Secretary (Financial Services) for Financial Services and the Treasury Bureau

Mr Justin To leads the policy team in the Financial Services and the Treasury Bureau in formulating Hong Kong's overall policy on anti-money laundering and counter-terrorist financing (AML/CFT), as well as collaborating with the SFC and other financial regulators in the implementation of relevant initiatives in the financial services sector. In addition, he and his team are also responsible for matters relating to banking policy, bond market development, and the policy on regulating virtual asset activities.

Prior to his current role, Mr To worked on a range of policy areas including urban and town planning, transport planning, and welfare service planning in Hong Kong.

He joined HKUST in 1992 as a founding member of the Business School and was Dean of the Business School from 2016 - 2024.

Professor Tam is well known for his contributions in Fintech and the diffusion of innovations in organizations. His earlier work on machine learning applications in finance and investment is regarded as pioneer research in Fintech.

Professor Tam is currently the Chairperson of the Hong Kong Committee for Pacific Economic Cooperation of the HKSAR and a member of the Exchange Fund Advisory Committee of the Hong Kong Monetary Authority. He serves on the Board of the European Foundation for Management Development (EFMD) and was the President of the Association of the Asia Pacific Business Schools (AAPBS).

She works closely with the industry to identify emerging money laundering risks and to develop appropriate regulatory responses. She is also actively engaged in international AML/CFT initiatives, including the Financial Action Task Force (FATF), where she contributes to the development of global standards.

Mr Jonathan Ng specialises in AML/CFT and financial crime compliance (FCC) with 18 years of experience in the banking and securities industry.
