

**L.N. 29 of 2004****RECTIFICATION OF ERRORS ORDER 2004**

(Made under section 98A of the Interpretation and General Clauses Ordinance (Cap. 1) on the authority of the Secretary for Justice pursuant to section 7 of the Legal Officers Ordinance (Cap. 87))
