Proposed Privatisation of JCG Holdings Limited
by Way of a Scheme of Arrangement and Withdrawal of Listing -
Disclosure of Dealings in Relevant Securities in JCG Holdings Limited (JCG) 1 August 2003

As a result of the above dealings, Public Bank Berhad holds 438,958,110 shares in JCG, representing 62.02% of the JCG's issued capital.
