Famex is the offeror. Famex is an indirect wholly-owned subsidiary of ITC Corporation Limited ("ITC"). Dr. Chan Kwok Keung, Charles is interested in approximately 34.52% of ITC.

The resultant balance of 121,791,307 shares, representing approximately 48.22% of the issued share capital of Hanny, includes 108,508,916 shares interested by Famex, 3 shares held by Hollyfield Group Limited (an indirect wholly-owned subsidiary of ITC Corporation Limited), 1,627,697 shares interested by Chan Kwok Keung, Charles, 1,600,000 shares held by Chan Kwok Hung, 6 shares held by Cheung Hon Kit, 32 shares held by Shek Lai Him, Abraham, 52,000 shares held by Cheung Shu Wan and 10,002,653 shares held by Cobbleford Limited.
