CLARIFICATION ANNOUNCEMENT

Given the substantial amount of rumour and speculation circulating on this matter, PCRD and Starvest would like to confirm that neither PCRD, Starvest nor any of their respective directors had any knowledge of or involvement in any improper activities. PCRD and Starvest also confirm that although Fortis Asia Holdings Limited (formerly called Pacific Century Insurance Holdings Limited), which is the holding company of Fortis Insurance Company (Asia) Limited, was once a subsidiary of PCRD, it ceased to be a subsidiary of PCRD on 15 May 2007. There is no longer any connection between Fortis Asia Holdings Limited and PCRD.
