- (2) The Company and the Appointee wish to enter into this Supplemental Agreement to amend certain terms of the Appointment Letter in the manner as set out in this Supplemental Agreement.

BY WHICH IT IS AGREED as follows 双方协议如下:

1. <u>Definitions and interpretation 定义和解释</u>

In this Supplemental Agreement (including the recital herein), unless specifically provided otherwise, capitalised words or expressions used herein shall have the ascribed to them in the Appointment Letter.

2. Amendment to the Appointment Letter 委任函之修订

Clause 9 of the Appointment Letter shall be deleted in its entirety and replaced by the following:-

"9. Commencing from the Commencement Date, you shall be entitled to a monthly director's fee in the sum of HK\$25,000 accruing from the Commencement Date or such sum as the board of directors of the Company and the remuneration committee of board of directors of the Company may from time to time decide. The above director's fee shall be payable in arrears on the last day of each calendar month, provided that: (i) in respect of the monthly director's fee for the period from the Commencement Date to 31 March 2025, you shall be entitled to a proportionate part of such fee in respect of the period of service commencing from the Commencement Date up to 31 March 2025 (both dates inclusive), which shall be payable on the last day of April 2025; and (ii) if the appointment hereunder is terminated without any default of you prior to the end of a calendar month, you shall only be entitled to a proportionate part of such fee in respect of the period of service during the relevant month up to the date of termination."
