1. The 2nd Respondent shall not, without leave of the Court, for a period of 6 years with effect from the date hereof:
 - (i) be, or continue to be, a director, liquidator, or receiver or manager of the property or business, of any listed or unlisted company in Hong Kong including the 5th Respondent or any of its subsidiaries and affiliates; and
 - (ii) in any way, whether directly or indirectly, be concerned, or take part, in the management of any listed or unlisted company in Hong Kong including the 5th Respondent or any of its subsidiaries and affiliates.

2. The 2nd Respondent shall pay the Petitioner’s costs, to be taxed if not agreed.
