1. The 3<sup>rd</sup> Respondent shall not, without leave of the Court, for a period of 6 years with effect from the date hereof:
  - (a) be, or continue to be, a director, liquidator, or receiver or manager of the property or business, of any listed or unlisted company in Hong Kong including the 5<sup>th</sup> Respondent or any of its subsidiary and affiliates (as defined in Appendix 1 to the Schedule); and
  - (b) in any way, whether directly or indirectly, be concerned, or take part, in the management of any listed or unlisted company in Hong Kong including the 5<sup>th</sup> Respondent or any of its subsidiary and affiliates (as defined in Appendix 1 to the Schedule).
2. The 3<sup>rd</sup> Respondent shall pay the Petitioner's costs of proceedings in the sum agreed.
