2. there be no order as to the costs of the present proceedings, and the Petitioner and the 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> Respondents shall waive all their respective claims for costs awarded under any of the previous orders made in these proceedings.
